NOTIFICATION

G.S.R. No. 216-E. In exercise of the power conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (LXI of 1951) read with sub-rule (1) and (2) of rule 4 of the Indian Police Service (Cadre) Rules, 1954, the Central Government, in consultation with the Government of Punjab hereby makes the following regulations further to amend the Indian Police Service (Fixation of Cadre Strength) Regulations, 1955, namely: -

1. (i) These regulations may be called the Indian Police Service (Fixation of Cadre Strength) Fifth Amendment Regulations, 2003.
(ii) They shall come into force on the date of their Publication in the official Gazette.
2. In the Schedule to the Indian Police Service (Fixation of Cadre Strength) Regulations, 1955 under the heading "Punjab" for the entries occurring there- under, the following shall be substituted, namely: -
