A) CRIME BULLETIN

AMRITSAR CITY DISTT. (SNATCHING)

On 30.7.2010, Harpal Singh @ Pala s/o Rajbir Singh r/o Dadra Ajnala snatched cash Rs. 30,000/- from Daljit Kaur w/o Rattan Singh r/o Gali Nirankari Bhawan Bhikhiwind Tarn Taran, in the area of PS 'A' Division Amritsar. Case FIR No. 162 dated 30.7.2010 u/s 382 IPC PS 'A' Division Amritsar has been registered in this regard. No arrest so far.

II) (ATTEMPT TO MURDER)

On 30.7.2010, Happy Ghora alongwith some of his accomplices attempted to kill Ved Parkash s/o Heera Lal r/o Plot No. 131 Preet Vihar with fire arms. Case FIR No. 82 dated 30.7.2010 u/s 307/148/149 IPC & 25/27/54/59 Arms Act PS Cantonment Amritsar has been registered in this regard. No arrest so far.

II) (RECOVERY OF DEAD BODY)

On 30.7.2010, Police party of PS Sultanwind recovered a dead body of an unknown lady near S.W. Canal PS Sultanwind. Case FIR No. 126 dated 30.7.2010 u/s 302/201 IPC PS Sultanwind has been registered in this regard. No arrest so far.

FEROZEPUR DISTT. (KIDNAPPING/RAPE)

On 7.7.2010, Ravinder Singh s/o Chand Singh alongwith two of his accomplices kidnapped & raped Meeto Bai (23 years old) d/o Rulya Singh r/o Rana. Case FIR No. 113 dated 30.7.2010 u/s 365/376/500/509/506 IPC & 67 Information Technology Act year 2000 PS Sadar Fazilka has been registered in this regard. No arrest so far.

II) (KIDNAPPING-FEMALE)

On the intervening night of 9/10.7.2010, Sonu s/o Tarsem Singh r/o Ward No. 2 Karanpur Ther (RAJ) alongwith three of his accomplices kidnapped Veerpal Kaur d/o Gajjan Singh r/o Gobind Nagri Jalalabad. Case FIR No. 111 dated 30.7.2010 u/s 363/366-A, IPC PS City Jalalabad has been registered in this regard. No arrest so far.

FATEHGARH SAHIB DISTT. (MURDER)

On the intervening night of 29/30.7.2010, Pawan Mehta s/o Chander Shri Mehta r/o Gumel (Bihar) murdered Dinesh Kumar (17 years old) s/o Siyaram r/o Barbali Kalan with sharp edged weapons. Case FIR No. 82 dated 30.7.2010 u/s 302/506 IPC PS Khammo has been registered in this regard. No arrest so far.

KHANNA DISTT. (ASSAULT ON POLICE PERSONNEL)

On 30.7.2010, Sikandar Singh s/o Bikkar Singh r/o Chakli Kasab alongwith seven of his accomplices assaulted HC Satwant Singh and torn off his uniform, who was on duty at Sherpur Basti PS Machhiwara. They also damaged the car No.DL-3-CW-7236 and stole car battery. Case FIR No. 157 dated 30.7.2010 u/s 353/186/336/427/506/323/148/149 IPC PS Machhiwara has been registered in this regard. No arrest so far.

MOGA DISTT. (ONE-HELD)

On 30.7.2010, Police party of PS Badhni Kalan arrested Sukhwinder Singh s/o Ranjit Singh r/o Rania and recovered one .315 bore country made pistol with one live cartridge from his possession. Case FIR No. 71 dated 30.7.2010 u/s 25/54/59 Arms Act PS Badhni Kalan has been registered in this regard.

II) (RAPE)

On 25.7.2010, Sukhwinder Kumar s/o Kartar Chand r/o Bakhiaur PS Mukandpur alongwith three of his accomplices murdered Kulwant Singh s/o Mohinder Pal r/o Bahadurpur. Case FIR No. 71 dated 30.7.2010 u/s 302/201/34 IPC PS Sadar Nawan Shehar has been registered in this regard. No arrest so far.

TARN TARAN DISTT. (ONE-HELD)

On 30.7.2010, Police party of PS City Tarn Taran arrested Prem Singh @ Prema s/o Swaran Singh r/o Alago Kalan Bahar Behak and recovered one .315 bore country made pistol with 5 live cartridges from his possession. Case FIR No. 180 dated 30.7.2010 u/s 25/54/59 Arms Act PS City Tarn Taran has been registered in this regard.
