A) CRIME BULLETIN

AMRITSAR CITY DISTT. (ATTEMPT TO MURDER)

On 29.7.2010, Prince Ladla s/o Lakhwinder Singh r/o Gali No. 1, Kartar Nagar Chheharta alongwith some of his accomplices attempted to kill Rakesh Sharma s/o Ashwani Sharma r/o 3102, Gali Mills Subhash Road Chheharta Amritsar with fire arms. Case FIR No. 175 dated 29.7.2010 u/s 307/452/506/148/149 & 25/27/54/59 Arms Act PS Chheharta has been registered in this regard. No arrest so far.

GRP/PATIALA (ATTEMPT TO MURDER)

On 29.7.2010, Mour Singh alongwith 11 of his accomplices attempted to kill Raj Kumar s/o Munshi Ram r/o # 218 Nabha, near infront of Railway Station PS GRPS Patiala. Case FIR No. 59 dated 29.7.2010 u/s 307/323/324/341/149/34 IPC PS GRPS Patiala has been registered in this regard. No arrest so far.

HOSHIARPUR DISTT. (SNATCHING, TWO-HELD)

PATIALA DISTT. (RAPE)

Seven month ago, Gurjit Singh @ Sunny s/o Karam Singh r/o 27, Babu Singh Colony Ablowal Patiala raped Pooja d/o Ram Saroop r/o 41 Street No. 4, Range Shah Colony Patiala. Case FIR No. 29.7.2010 u/s 376 IPC PS Kotwali Patiala has been registered in this regard. No arrest so far.

II) (MURDER)

On 7.7.2010, Pritam Singh r/o Bhawanigarh murdered his daughter-in-law Jaswant Kaur. Case FIR No. 288 dated 29.7.2010 u/s 302/120-B, IPC PS Tripuri has been registered in this regard. No arrest so far.

III) (ATTEMPT TO MURDER)

On 29.7.2010, Bihari Lal s/o Tehani Ram r/o Bohran Gate Nabha alongwith twenty three of his accomplices attempted to kill Raj Singh s/o Birbal Singh with sharp edged weapons. Case FIR No. 118 dated 29.7.2010 u/s 307/323/341/148/149 IPC PS Kotwali Nabha has been registered in this regard. No arrest so far.

IV) (SNATCHING)

On 29.7.2010, three unknown persons snatched a purse containing cash Rs. 1500/-, one mobile phone, some gold ornaments and other documents from Kawaljit Kaur w/o Satbir Singh r/o 17-A, Baba Sri Chand Marg Sirhind Road Patiala. Case FIR No. 289 dated 29.7.2010 u/s 356/379 IPC PS Tripuri has been registered in this regard. No arrest so far.

TARN TARAN DISTT. (MURDER)

On 29.7.2010, Harbans Singh @ Bansi s/o Natha Singh r/o Naushehra Dhala alongwith one of his accomplice murdered Tej Kaur w/o Balbir Singh r/o the same place and injured her son Balwinder Singh with sharp edged weapons. Case FIR No. 50 dated 29.7.2010 u/s 302/323/34 IPC PS Sarai Amant Khan has been registered in this regard. No arrest so far.

II) (ONE-HELD)

On 29.7.2010, Police party of PS Valtaha arrested Roop Singh s/o Mukhtiar Singh r/o Sangwan and recovered one .12 bore country made pistol with one live cartridge from his possession. Case FIR No. 86 dated 29.7.2010 u/s 25/54/59 Arms Act PS Valtaha has been registered in this regard.
