A) CRIME BULLETIN

AMRITSAR RURAL DISTT (FIVE TERRORISTS HELD)

State Special Operation Cell Amritsar arrested five terrorists (belongs to Babbar Khalsa Group) namely; Gurmukh Singh @ Gana r/o Pandori Mehma, Kulwant Singh @ Raju s/o Sadha Singh r/o Verpal on 25.7.2010, Darshan Singh Dhabi s/o Teja Singh r/o Dhaliwal Jalandhar on 26.7.2010, Pal Singh s/o Ranjit Singh r/o Village Dhandowal PS Shahkot and Jagtar Singh s/o Gurdeep Singh r/o Thobe PS Ramdas on 27.7.2010. Two AK-47 Rifles, 5 magazines and 620 cartridges recovered from their possession in case FIR No. 24 dated 25.7.2010 u/s 25/54/59 Act & 17/18/19 Unlaw Full Activities Prevention PS S.S.O.C has been registered in this regard.

BARNALA DISTT. (SUICIDE)

On 28.7.2010, Ino Devi w/o Asha Ram r/o town & PS Dhanaula committed suicide by consuming poison due to harassment by Ramandeep Singh s/o Gurcharan Singh r/o Dhilwan Patti PS Dhanaula. Case FIR No. 95 dated 28.7.2010 u/s 306 IPC PS Dhanaula has been registered in this regard. No arrest so far.

FARIDKOT DISTT. (ATTEMPT TO MURDER)

On 28.7.2010, Gurfateh Singh s/o Bhupinder Singh r/o near Church Amar Nagar PS City Faridkot attempted to kill his wife Gurnam Kaur by strangulation for dowry. Case FIR No. 220 dated 28.7.2010 u/s 307/323/498-A IPC PS City Faridkot has been registered in this regard. No arrest so far.

HOSHIARPUR DISTT. (SNATCHING)

On 28.7.2010 at about 2.30 PM, two unknown motorcycle borne persons snatched a bag containing cash Rs. 4,51,000/- from Mohan Singh s/o Ram Datta r/o Alo Bhatti, near Tehsil Mukerian Hazipur Road PS Mukerian. Case FIR No. 103 dated 28.7.2010 u/s 382/34 PS Mukerian has been registered in this regard. No arrest so far.

II) (ASSAULT ON POLICE PERSONNEL, FOUR HELD)

On 28.7.2010, Bhagwan s/o Nathu Singh s/o village Chohal PS Sadar Hoshiarpur along with three of his family members attempted to kill Inspector Sita Rani No. 828/JR, Incharge Highway Range Jalandhar and other police personnel with fire arms. They also tore their uniform and tried to hit the police party with their car. All accused arrested. Case FIR No. 119 dated 28.7.2010 u/s 307/353/186/509 IPC & 25/54/59 Arms Act PS Sadar Hoshiarpur has been registered in this regard.

KAPURTHALA DISTT. (ASSAULT ON POLICE PERSONNEL)

On 28.7.2010, Tilak Raj r/o Bhulath along with 15/16 of his accomplices attempted to kill the police party of PS Bhulath with blunt/sharp edged weapons when they were on duty at Taxi Stand town & PS Bhulath. Case FIR No. 81 dated 28.7.2010 u/s 307/353/186/332/148/149 IPC PS Bhulath has been registered in this regard. No arrest so far.

II) (MURDER)

Few days ago, unknown person murdered Shakuntala Devi w/o Dharamvir Singh r/o Mohalla Mulkana PS City Kapurthala. Case FIR No. 115 dated 28.7.2010 u/s 302 IPC PS City Kapurthala has been registered in this regard. No arrest so far.

III) (ONE DACOIT HELD)

On 28.7.2010, police party of PS Bhulath arrested Amarjit Singh s/o Mahinder Pal Singh r/o Hassan Munda PS Kartarpur when he along with four other dacoits were planning to commit dacoity at Cremation Ground town & PS Bhulath. One .12 bore country made pistol with one live cartridge recovered from his possession. Case FIR No. 399/402 IPC & 25/54/59 Arms Act PS Bhulath has been registered in this regard.

LUDHIANA CITY DISTT. (ATTEMPT TO MURDER)

On 28.7.2010, Maninder Sharma r/o Preet Nagar PS Shimlapuri along with 11/12 of his accomplices attempted to kill Pardeep Kaur s/o Bhag Mall r/o New Kartar Nagar Ludhiana and stole Rs.3200/- and a gold chain from him at Dushehra Ground town & PS Shimlapuri. Case FIR No. 176 dated 307/323/324/379/506/148/149 IPC PS Shimlapuri has been registered in this regard. No arrest so far.

LUDHIANA RURAL DISTT. (ATTEMPT TO MURDER)

On 28.7.2010 at about 10.45 AM, Beant Singh s/o Gurdial Singh r/o village Jhordan attempted to kill Chaman Lal s/o Mulana Ram r/o Mohalla Balmik PS Raikot with fire arm. Case FIR No. 151 dated 28.7.2010 u/s 307 IPC & 25/27/54/59 Arms Act PS Raikot has been registered in this regard. No arrest so far

RUPNAGAR DISTT. (SNATCHING)

On 26.7.2010 at about 3 PM, Saranjit Singh and Darshan Singh snatched Rs.1800/- from Naushad s/o Shoukat r/o Ward No.5 PS Kurali on knife point near village Fathegarh Chotali PS Singh Bhagwant Pur. Case FIR No. 37 dated 28.7.2010 u/s 382/34 IPC PS Singh Bhagwant Pur has been registered in this regard. No arrest so far

S.B.S. NAGAR DISTT. (KIDNAPPING/RAPE)

On 6.7.2010, Rakesh Kumar s/o Prem Nath r/o Bholewal Kadian PS Ladawal kidnapped and raped Parveen Kaur d/o Dharampal Adharmi r/o Gadani PS Behram. Case FIR No. 37 dated 28.7.2010 u/s 363-A/366/376 IPC PS Behram has been registered in this regard. No arrest so far

II) (SNATCHING)

On 24.7.2010 at about 12 Noon, Raj Kumar s/o Ashok Kumar r/o town & PS Rajkot Distt. Kaithal (HYA) snatched an Indica car No. PB-10-CM-9445 from Khushal Singh s/o Amar Singh r/o Ward No.10 Barnala Road Nawan Shehar, at Garhshanker Road PS City Nawan Shehar. Case FIR No. 91 dated 28.7.2010 u/s 382 IPC PS City Nawan Shehar has been registered in this regard. No arrest so far

SANGRUR DISTT. (MURDER)

On 28.7.2010 at about 3 PM, Nahar Singh s/o Hakam Singh r/o Nehal Kalan PS Moonak along with some of his accomplices murdered Jaswinder Singh s/o Ajaib Singh r/o the same place with fire arms. They also inured his brother Jagsir Singh and his father with blunt/sharp edged weapons. Case FIR No. 110 dated 28.7.2010 u/s 302/307/341/336/323/324/148/149 IPC & 24/54/59 Arms Act PS Moonak has been registered in this regard. No arrest so far
